#### Instructions Relating to Shortage of Attendance & Permission for writing examination

- 1. Attendance exemption is not granted as a matter of course; it will be granted only in cases where the students could not attain 75 percent of the attendance for reasons beyond their control, provided the shortage of attendance is within the specified limit as per clause 8.2 in regulations R17.
- 2. Attendance exemption will be decided by
  - ✓ the recommendations of a committee constituted by the Principal and
  - ✓ Approval of Principal
- 3. Applications for attendance exemption & writing end semester examinations should be submitted in the prescribed Format showing the days of absence during the academic year with reasons for each days of absence.
- 4. In the case of illness such applications should be supported by proper Medical Certificate.

- 5. Applications which are not specifically recommended by the HoD / Committee / Principal will not be considered.
- 6. Applications not conforming to the regulations will not be considered.
- 7. The HoDs should not forward the applications of students who have shortage of attendance below 65%. (he/she has to register for summer track as per clause 7.5.1 in regulations R17)
